

Fishing for Free Play Official Rules

Promotional Period: December 4, 2024, at 10AM – December 18, 2024, at 10PM **Redemption Dates:** Every Wednesday in December from 10AM – 10PM (*Excluding December 25*)

Prize Minimum: \$5 Free Play **Prize Maximum:** \$1,000 Cash

- 1. To be eligible for this promotion, player (hereafter "player" or "players") must be a current ONE club member in good standing.
- 2. Guests must be a ONE club member, or enroll to become one, to be eligible.
- 3. New members are qualified for this promotion upon valid enrollment.
- 4. This promotion will occur on Wednesday; December 4, 11 and 18, 2024, from 10AM-10PM.
- 5. Guests must earn two-hundred (200) promo slot points to qualify for the first attempt. Bonus points do not qualify.
- 6. Player must visit a ONE club promotional kiosk
 - a. Swipe player's ONE club card
 - b. Select Promotions tile
 - c. Enter valid PIN
 - d. Select Fishing for Free Play tile
 - e. Follow game prompts
- 7. Guests are limited to two (2) attempts each Wednesday upon reaching 200 and 800 promo slot points.
- 8. Qualification, participation and redemption requirements for this promotion are limited to Quil Ceda Creek Casino.
- 9. All Free Play prizes awarded will be attached to the player's account and must be activated within four (4) hours from award.
- 10. Promo Free Play will expire twenty-four hours (24) hours from prize activation.
- 11. Free Play credits must be used at a slot machine; cash-out option is not available for this promotion.
- 12. Any Free Play that is not activated within the allotted activation period, or expired, will not be reissued.
- 13. All cash prizes awarded at the kiosk will print a receipt.
- 14. All prize receipts must be redeemed at the ONE club by the expiration date and time on the receipt.
